## A statement of familiarity with the information obligations of the final recipient and the beneficiary's project staff

With regard to participation in the project entitled "Open Zacheta. Digitization and access to Polish resources of contemporary art from the collection of the Zacheta - National Gallery of Art and the construction of IT tools, development competence of cultural personnel, animation and promotion for the use and processing of digital cultural resources for the purposes of educational, scientific and creative purposes." (hereinafter: "Open Zacheta") I declare that:

- 1. The administrator of the personal data provided within the framework of the implementation of the aforementioned project is the minister competent for regional development acting as the Managing Authority for the Operational Programme Digital Poland for 2014-2020, having its seat at Wspólna 2/4 Street, 00-926 Warsaw.
- 2. The processing of the submitted personal data is lawful and meets the conditions referred to in Article 6(1)(c) and Article 9(2)(g) of the Regulation of the European Parliament and of the Council (EU) 2016/679 the personal data are necessary for the implementation of the Operational Programme Digital Poland for 2014-2020 (OPDP) on the basis of:

    - b) European Commission Implementing Regulation No. 1011/2014 of September 22, 2014 laying down detailed rules for the implementation of Regulation European Parliament and of the Council (EU) No. 1303/2013 as regards the templates for the transmission of certain information to the Commission and detailed rules on the exchange of information between beneficiaries and managing, certifying, auditing and intermediate bodies (Official Journal of the EU L 286 of 30.09.2014, p. 1),
    - c) the Act of July 11, 2014 on the principles of implementation of programs in the area of cohesion policy financed in the financial perspective 2014-2020 (Journal of Laws of 2017, item 1460, as amended, );
  - 2) with regard to the collection "Central ICT system supporting the implementation of operational programs":
    - a) Regulation of the European Parliament and of the Council (EU) No. 1303/2013 of December 17 2013 establishing common provisions on the European Development Fund, Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development, and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Maritime and Fisheries Fund and repealing Council Regulation (EC) No. 1083/2006,

- b) the Law of July 11, 2014 on the principles of implementation of programs within the scope of cohesion policy financed in the financial perspective 2014-2020 (Journal of Laws of 2017, item 1460, as amended)
- c) European Commission Implementing Regulation No. 1011/2014 of September 22, 2014 laying down detailed rules for the implementation of Regulation European Parliament and of the Council (EU) No. 1303/2013 as regards the templates for the transmission of certain information to the Commission and detailed rules on the exchange of information between beneficiaries and managing, certifying, auditing and intermediary bodies (Official Journal of the EU L 286 of 30.09.2014, p. 1).
- 3. My personal data will be processed solely for the purpose of implementation of the "Open Zacheta" project, in particular, confirming the eligibility of expenses, providing support, monitoring, evaluation, control, auditing and reporting, as well as information and promotional activities under OPDP.
- 4. My personal data has been entrusted for processing to the Intermediate Body, i.e. the Digital Poland Projects Centre 13a, Spokojna St., 01-044 Warsaw, to the project beneficiary: Zacheta National Gallery of Art 3, Małachowskiego Sq, 00-916 Warsaw, the project partner: Foundation Centrum Cyfrowe, 24/2 Chmielna St., 00-020 Warsaw, as well as entities that, on behalf of the beneficiary, participate in the implementation of the project. The personal data provided may be transferred to entities carrying out evaluation research on behalf of the Managing Authority, Intermediate Body or the beneficiary. The transferred personal data may also be entrusted to specialized companies carrying out checks and audits on behalf of the Managing Authority, Intermediate Body and beneficiary controls and audits under OPDP.
- 5. Providing data is a prerequisite for receiving support and implementation of the project, and refusal to provide them provision is equivalent to the inability to provide support under the project.
- 6. Provided personal data will not be transferred to a third country or international organization.
- 7. Provided personal data will not be subjected to automated decision-making.
- 8. The transferred personal data will be stored until the settlement of the Operational Programme Digital Poland 2014 -2020 and completion of archiving of documentation.
